Submissions: Must be filled out completely on an official Car for A Cause nomination form. No self-nominations will be accepted.

Deadline: Official Car for A Cause nomination form can be submitted in person to any NAPA AutoCare SoCal member business no later than 5PM on Thursday November 30th, 2023.

Winner: will be selected by a panel on or around December 10th, 2023, and notified on or before December 14th, 2023.
